Mr. Aguilar Valdez has also an extensive expertise on matters regarding administrative litigation and judicial review, particularly, on such related to the public procurement and contracting, public utilities and Governmental

liability fields. He has been appointed as local counsel in some ICC and ICSID arbitration proceedings related to State and Government contracts.

He has acted as legal counselor for foreign investors in most of the privatization proceedings launched by the Argentine Government during the 90s. Likewise, he has participated in the design, drafting and negotiation of several public purchases, concessions and public private partnerships contracts as well in the project financing structure of several infrastructure projects.

As a consequence of the Argentine economic and financial crisis of 2001/2002, he has counseled several public utilities companies in the process of renegotiation of their concession contracts as well as some financial entities in the Argentina's Sovereign Debt restructuring process.

Mr. Aguilar Valdez has also drafted a bill of law for the Government of the City of Buenos Aires establishing a Public-Private Partnership Legal Framework.

He is Vice Chair of the Administrative Law Committee of the City of Buenos Aires Bar Association and member of the Administrative Law Institute of the National Academy of Law and Social Sciences, of the Legislative Studies Committee of the Argentine Federation of Bar Associations and of the International Bar Association (International Construction Law committee). Likewise, he is member of the Academic Board of *Revista El Derecho Administrativo* (publication of the Argentine Catholic University) and of the International Academic Board of *Revista Regulación Económica* (publication of the ESAN University, Perú).

For ten years, Mr. Aguilar Valdez taught Public Utility Regulation at the Master on Administrative Law at the Austral University where, during 2006-2007 terms, he was member of the Academic Board of the Administrative Law Department and Chair of the Administrative Law cathedra.
